This includes all areas of the hospital and clinic laboratory including hematology, chemistry, special chemistry, serology, blood bank, microbiology, and urinalysis. KEY RESPONSIBILITY #3: (20%) Maintain instrument and lab section as assigned by the Lab Manager. This includes scheduled maintenance and monitoring consumables. KEY RESPONSIBILITY #4: (20%) Perform specimen collection on patients of all age groups. This includes venipuncture, capillary draws, culturing sites, and instructing nursing staff on correct method of sample collection. Other duties as required.
